A Celebrated Jurist and Literary Genius

Hon'ble Mr. Justice Asif Saeed Khan Khosa was born in a distinguished family of welleducated bureaucrats and jurists on 21st December 1954 in Dera Ghazi Khan.

He has been a topper throughout his academic life and a recipient of National Talent Scholarship in his Matriculation from Multan (1969), Intermediate from Government College Lahore (1971), and his Bachelors from University of Punjab (1973). After his graduation with distinction, Mr. Justice Asif Saeed Khan Khosa did his Masters in English Literature from the University of Punjab in 1975, after which he went on to his Tripos-I from Queen's College, University of Cambridge, United Kingdom in 1977. Following successful completion of Tripos-I, Justice Khosa did his LL.M in 1978 in Public International Law with subjects of Law of Peace, the Law of War and Armed Conflict, the Law of International Institutions and the Law of Civil Liberties, from the same Queen's College, University of Cambridge in UK. Later, he was called to the Bar on 26th July, 1979, at the Honourable Society of Lincoln's Inn, London.

Mr. Justice Asif Saeed Khan Khosa was enrolled as Advocate Lahore High Court





Lahore in 1979, upon his return from UK. He was later enrolled as Advocate of the Supreme Court of Pakistan in 1985. As a young Advocate, Justice Khosa established his name as an illustrious lawyer by representing hundreds of important cases regarding matters of constitutional, criminal, civil, revenue, service, and electoral laws in the Supreme Court and High Court. He has over 600 reported cases to his credit. As member of the Bar, Justice Khosa has also served as Member of the Library Committee and as Member of the Executive Committee of the Lahore High Court Bar Association, Lahore.

On May 21, 1998, Mr. Justice Asif Saeed Khan Khosa was elevated to the Bench and appointed as a Judge of the Lahore High Court, Lahore. On February 18, 2010, Mr. Justice Asif Saeed Khan Khosa was appointed as a Judge of the Supreme Court of Pakistan, where he continues to serve till date. The Hon'ble Justice has decided over fifty thousand cases over a period of almost two decades.

Mr. Justice Asif Saeed Khan Khosa's passion for literature, learning and academic pursuits has always prompted him to take out time from his very busy professional life to read, teach, and write. His articles and research papers on a variety of key constitutional, legal and legislative issues have been published in a number of law journals, major law reports and newspapers of the country.

Prior to having been elevated to the Bench, Justice Khosa has been a part-time/visiting lecturer in some of the distinguished educational and training institutions including Bahauddin Zakariya University, Multan, Punjab University Law College, Lahore. He has been a visiting lecturer of Constitutional Law at the Civil Services Academy, Lahore; National Institute of Public Administration (NIPA), Lahore; National Police Academy, Islamabad; Staff Training Institute of the Services and General Administration Department of the Government of the Punjab; Training Course for Civil Judges conducted by the Lahore High Court, Lahore; and the Lahore University of Management Sciences (LUMS).

Mr. Justice AsifSaeed Khan Khosa' sillustrious career has won him many distinctions. Some of these are enlisted below:

- 1. Founding member of the SAARCLAW;
- 2. 2016 todate: Chairman Shariat Appellate Bench of the Supreme Court of Pakistan;
- 3. 2015 todate: Member of the Supreme Judicial Council of Pakistan;

- 5. 2008 todate: Elected member of the Board of Directors of the Commonwealth Judicial Education Institute, Halifax, Canada;
- 6. 2015 17.01.2019: One of the two member Administrative Committee of Federal Judicial Academy;

Hon'ble Mr. Justice Asif Saeed Khan Khosa has participated and addressed countless significant high profile conferences, seminars and symposia at the national and international level on topical issues pertaining to justice and legal sector.

Good leaders always put their house in order:

Mr. Justice Athar Minallah, Chief Justice, Islamabad High Court



Chief Justice, IHC, laments nepotism as one of the greatest evils in our society

The Certificate Awarding Ceremony of six-day training course on "Leadership and Management" for District and Sessions Judges was held at the Federal Judicial Academy (FJA) on January 12, 2019.

Chief Justice, Islamabad High Court, Hon'ble Mr. Justice Athar Minallah, distributed certificates as Chief Guest among twenty five heads of district judiciary from all over Pakistan and Azad Jammu and Kashmir. In his address, Hon'ble Chief Justice, IHC said that leadership and management training is vital for promoting and ensuring Rule of Law in the country.

"Being an effective leader is essential in order to make an impact within your organisation. A single good leader can create an endless chain of social change. First of all, a good leader always puts his or her house in order. District and Sessions Judges are important leaders of judicial system because district judiciary is an important tier of the administration of justice system "he maintained.

Honourable Chief Justice, IHC, in his address also enlightened the participants about some of the important leadership qualities of good leaders which include: Honesty, integrity, good communication, inspiring others, decision-making capabilities, amongst others. For all type of leaders whether they belong to sports, politics, judiciary or any other discipline, attributes of good leadership are the same. When a leader is honest, then, his honesty has the trickledown effect. District and Sessions Judges as leaders must put in practice their leadership attributes to reform the district judiciary and ameliorate the plight of the litigant public who are the key stakeholders in the administration of justice system."

Lamenting the growing nepotism in our society, he stated that, "The menace of nepotism has become a way of life in our society. As leaders, District and Sessions Judges must play the desired role to combat nepotism which has permeated into every fabric of society."

Speaking on the occasion, Director General of the Academy, Mr. Hayat Ali Shah stated that, "Leadership competencies contribute to superior performance. This training course was exactly tailored to meet individual training requirements."

Throughout the training, a wealth of knowledge and experiences were shared between the participants and erudite resource persons, subject specialists, coupled with faculty members.

Training course was carried out through syndicate discussions, group discussions, presentations and conducted in a participatory process. During the training, participants obtained an in-depth understanding of leadership and management for effective administration of justice system.

Hon'ble Mr. Justice Miangul Hassan Aurangzeb, Judge, IHC urges district judiciary judges to stop clogging courts with frivolous litigations



The Federal Judicial Academy, Islamabad, held the certificate awarding ceremony at the conclusion of a- one week capacity building training course for Civil Judges from all over Pakistan here at the Academy on March 16, 2015 in which Hon'ble Mr. Justice Miangul Hassan Aurangzeb , Judge, Islamabad High Court was invited as the Chief Guest.

Mr. Justice Miangul Hassan Aurangzeb stated that, "Inadequate legal knowledge and skills weaken the credibility and efficiency of the judicial system and impede its proper functioning. Knowledge should be exercised to create a better society. We have to leave a good legacy for future generations."

He noted that judges require appropriate training to discharge their duties effectively.

Lamenting the "frivolous ligation culture" in courts, Judge, IHC said that, "It is high time to discourage frivolous litigation, adopting dilatory tactics by taking adjournments, pleading contradictory stands before the courts, among others. Judges must impose realistic costs and send a glaring message to restrict the unscrupulous and frivolous litigants from wasting valuable judicial time for wrongful gains. Judges of the subordinate courts must exercise their powers to discourage frivolous litigation. Mediation and ADR mechanisms should be adopted to improve dispensation of cases."

Offering his congratulations to the trainees, Honourable Judge, IHC, urged them to exercise self-discipline in handling every case at work. He also spoke about his decadeslong association with the Academy as a lawyer, resource person and now as Judge of High Court.

Director General of the Academy, Mr. Hayat Ali Shah delivered the welcome address and also presented an overview of the capacity building training course at the certificate awarding ceremony.

He commended the trainees' passion for learning and excellence, and wished them every success upon returning to their position in the field. Advising them, DG said, "It always takes commitment, hard work, determination and perseverance to achieve what you want to achieve".

Our courts need dynamic leaders: Director General, Federal Judicial Academy

A six-day training course on "Leadership and Management" for District and Sessions Judges was formally inaugurated at the Federal Judicial Academy (FJA) on January 7, 2019.

While addressing the participants, Director General of the Academy, Mr. Hayat Ali Shah stated that, "Our courts need strong leaders. This is the second batch for training on the same subject "Leadership and Management." He further said that being senior judicial officers they do not need any training in law but due to changed scenario every District Judge has to act as a leader in his district and he has to know many things about other institutions to further the case of justice delivery.

environment.

The program was facilitated by the FJA faculty members who were at the forefront of thought leadership and practice. Topics this course included, in "Understanding Challenges at the "Critical Workplace", Thinking", "Emotional Intelligence", "Stress "Team Management", Building through Engagement", "Management Communication Skills", "Deontology-The Judges Perspective", among others.

Each day involved lectures, interspersed with syndicate discussion, group presentation, individual command tasks, etc.

This training course also featured many opportunities for networking, socialization and engagement with faculty and other experts such as Work Planning, Academy Night and Special Dinner.

The training course increased their understanding of what it means in practice to be an independent and impartial judge.

The topics and discussions focused specifically on the issues that confront Additional District and Sessions Judges in their daily court proceedings and prepare the participants to uphold the high standards of professionalism.

Several topics were discussed during this six days long training course, relevant to the job of Additional District and Sessions Judge in Pakistan. These topics including "Emotional Intelligence", "Theories of Criminology", "Soft Skills", Sessions Trial", " " Management of Professional Ethics", " Juvenile Justice System Act, 2018, "Perspective on Digital Investigation and Evidence", " Dealing with Lunatics, Criminal Trial and Mental Health Ordinance", " Use of Modern Technologies for Recording of Evidence: Concept of e-court", "Law of Inheritance", ' Law of Defamation", " New Dimensions in Medical Jurisprudence", amongst others.

FJA to arrange trainings for enhancing professional capabilities and skills of Investigation Officers.

In the backdrop of the Meeting of "Steering Committee on Police Reforms" held on February 11, 2019 under the chairmanship of Hon'ble Mr. Justice Asif Saeed Khan Khosa, Chief Justice of Pakistan/Chairman, FJA, in which his lordship had observed that the Judicial Academies across the country should arrange trainings for Investigation Officers

for enhancing their professional capabilities and skills, the prime judicial training institute of the country, the Federal Judicial Academy held the "Training Need Assessment Through Focused Group Discussion" at the Phase-II Building of Federal Judicial Academy on March 20, 2019.

The FGD began with a welcoming address by Director General of the Academy, Mr. Hayat Ali Shah. The FGD was held for as long as 3 hours and discussed a host of issues related to capacity building of Investigation Officers in the light of short comings as pointed out by judicial verdicts at all levels.

"We are hosting this FGD to take constructive input from the learned participants on a variety of issues related to Training Need Assessment," said the DG in his opening remarks.

Besides faculty members, this FGD was attended by a group of Judicial Officers posted at Islamabad lead by a Senior Additional District & Sessions Judge and included Senior Civil Judges.

From Police side a group of Local Police Officers lead by AIG Establishment including officers dealing with Prosecution. Following the decision of the National Iudicial (Policy Making) Committee (NJPMC), and also the aforementioned meeting of the Police Reforms Committee, under the Chairmanship of Hon'ble Mr. Justice Asif Saeed Khan Khosa, Chief Justice of Pakistan/Chairman FJA, in which it was noted that Judicial Academies country wide should arrange trainings of Investigation Officers (IOs) for enhancing their professional capabilities and skills. The formation of this focused group called "Training Need Assessment FGD" was constituted to provide effective training to Investigation Officers, amongst others.

This was the 1st meeting of the FGD and more such like meetings will also be held in future for effective input from all key players for effective trainings to the Investigation Officers.

One day cluster based training was arranged at the Federal Judicial Academy, Islamabad, for Key Punch Operators/ Data Entry Operators attached with Model Criminal Trial Courts in KPk and Balochistan on March 28, 2019. It was the first event in connection with the training series for professional development of KPOs/ DEOs during this month. The second training was conducted on March 29, 2019.

The training was formally inaugurated by Director General of the Academy, Mr. Hayat Ali Shah. While addressing the participants, the DG stated that, "Effective and efficient case flow promotes justice and upholds the very purpose of our courts. The Hon'ble Chief Justice of Pakistan is determined to expedite dispensation of justice. In the wake of Expeditious Justice Initiative, these specialized courts called "Model Criminal Trial Courts (MCTCs) have been established, to provide speedy justice to the justiceseekers. This training is designed to enhance your professional capabilities and skills."

The DG of the Academy also shed light on the mandate and mission of the Academy. He also expressed his sincere thanks for the honourable Chief Justice, Sindh High Court (SHC), who granted permission to the two IT Experts of the High Court to come all way to the Academy and impart training to the

trainees from KPk and Balochistan.

Training sessions on "An Introduction to CFMS" and "Hands on training on CFMS" was conducted by Mr. Arif Khan, Deputy Director, Information Technology (Hardware) and Mr. Sarmad Maher, Data Processing Officer, High Court of Sindh, respectively.

The participants of this one day training were awarded certificates by the DG, FJA, to conclude this ceremony in graceful and dignified manner.

Following the decision of the National Judicial (Policy Making) Committee (NJPMC), under the chairmanship of Hon'ble Chief Justice of Pakistan, Mr. Justice Asif Saeed Khan Khosa, the Chief Justices of the respective High Courts have ordered the establishment of one Model Criminal Trial Court (MCTC) in every judicial district of the province(s) in accordance with the Constitution that ensures inexpensive and expeditious justice and the right of a fair trial.
