#### REFORMS MUST FOR INSTITUTION OF JUDICIARY

#### Hon'ble Chief Justice of Pakistan

Hon'ble Mr. Justice Iftikhar Muhammad Chaudhry, Chief Justice of Pakistan has said that the institution of judiciary has earned reputation, hence, the reforms were 'sine qua non' for an effective and efficient administration of justice in the country.

He expressed these views while presiding over the thirty-seventh meeting of the Board of Governors of the Federal Judicial Academy, on Saturday, 15th December, 2012, in which a number of items on the agenda were discussed at length and a host of decisions were taken inter alia for the elevation of the Academy as varsity, welfare of the employees of the Academy, continuing judicial education in the country, standardization and institutionalization of trainings for Judicial officers.

Showing his concern regarding the welfare of the employees, Hon'ble Chief Justice of Pakistan said that there must be career development avenues in the Academy.

On this occasion Uniform Draft Rules for promotion of judicial officers linked with training at Federal Judicial Academy, were adopted. To this Hon'ble Chief Justice of Pakistan said that these rules were in the interest of the judicial officers. Their promotions should be linked with their trainings here in this Academy. Like other services such as the member of the civil services who undergo certain trainings at their respective institutions, our judicial officers should also undergo certain trainings linked with their promotions.

Speaking about "Training of Afghan Judges in Federal Judicial Academy, Islamabad," Hon'ble Chief Justice of Pakistan observed: "Since they are striving for the rule of law in our brotherly country of Afghanistan, hence, we have to help them. We have to impart trainings to their judicial officers and for that he directed the FJA management to expedite the process".

# JUDGES SHOULD ENSURE EXPEDITIOUS AND FAIR TRIAL TO ALL

Hon'ble Mr. Justice Tassaduq Hussain Jillani, Judge, Supreme Court of Pakistan has opined that providing justice to people is one of the foundational functions of the State and various institutions had been established under the Constitution and law which discharge this function, adding "it is a constitutional command in terms of Article 37(d) that the State shall, "ensure inexpensive and expeditious justice".

He expressed these views in the inaugural ceremony of one-week training course titled "How to be an effective Senior Civil Judge" arranged for Senior Civil Judges hailing from all over Pakistan including Azad Jammu and Kashmir and Gilgit-Baltistan at the Federal Judicial Academy, Islamabad on Monday 8<sup>th</sup> October, 2012.

He said: "The district judiciary is one of the pillars of the justice system geared towards that end. It is here that 70 to 80% of the litigation is pending; it is here that the litigants get first feel of the justice system; it is here that the image of judiciary as an institution is made or marred. It is, therefore, important that judges should ensure expeditious and fair trial to all".

Regarding mechanism to curtail litigation he said: "All civilized societies have endeavored to evolve and develope their own mechanisms to curtail litigation and to provide expeditious justice. Some of those mechanisms developed are arbitration, reconciliation, mediation and other modes of alternative dispute resolution. In our country, besides the family law even in the Code of Civil Procedure, a special provision has been inserted in terms of section 89-A to enable the courts and parties to resort to ADR. Unfortunately these mechanisms have yet to be practiced to a desirable extent, failure whereof has resulted in delayed justice".

Regarding the role of district judiciary in the enforcement of fundamental rights he said: "It is imperative that judges at the district level should clear off the misconception that it is the function of the superior courts alone to ensure enforcement of

fundamental rights. Every Judge, be it a civil judge of third class or of a higher level is called upon to enforce this right almost in every case and other fundamental human rights in appropriate cases. If Judges at this level are conscious of this dimension of their functions, hundreds of individual grievances can be redressed at this level".

Shedding light on the job description of a senior civil judge, Hon'ble Judge of the Apex Court said: "A Senior Civil Judge, as the job description and functions indicate, is a judge who is required to be an able administrator. He is to overview the working of the ministerial staff; he has to distribute the newly instituted cases among the civil judges; he has to frame issues; he has to monitor the working of the process serving agency and he is to carry out discovery, inspection and admission. He should ensure that life of a case is not prolonged. He has to manage the ministerial staff intelligently and imaginatively. He has to provide them leadership, motivation and a commitment. He also has to keep a positive relationship with the bar which should inter alia reflect fairness and impartiality".

"A Senior Civil Judge is first among the equals in his jurisdiction. In the said capacity, he has a leadership role to play and should be a role model for his peers both in his court conduct as also in his judicial work. He should remember that judging is not merely a job or an occupation providing salary, perks and status but also a way of life and if he has that spirit in mind it becomes more challenging and satisfying. Some of the things that he and every judge should always endeavour to pursue and strive include: a fair trial, a fair judgment and skills in the art of judgment writing. In a criminal trial while deciding the question of sentence, besides keeping the law in view, he should always follow the principle of proportionality, while conducting the court, he must radiate fairness, dignity and balance, he should never be complacent about himself and should keep updating his knowledge about the latest developments in law", honouable judge concluded.

Earlier, Mr. Parvaiz Ali Chawla, Director General of the Academy presented his welcome speech and spoke about the importance and scope of this short course.

Twenty senior civil judges participated in this one week training course at the Academy in which two were female, one from KPK district judiciary and the other from Balochistan district judiciary.

### DISPENSATION OF EXPEDITIOUS, INEXPENSIVE JUSTICE 'SINE QUA NON' FOR GOOD GOVERNANCE

Hon'ble Mr. Justice Iqbal Hameed-ur-Rehman Chief Justice of Islamabad High Court, opined that making arrangements for speedy and inexpensive justice is the responsibility of the executive but you (judges) may adopt such measures which can help us to achieve the objective of a just society, saying ,"Just and good society is not a secluded aspect but we all are also parties to it and the beneficiaries".

He expressed these views at the certificate awarding ceremony of one week training course titled, "How to be an effective Senior Civil Judge" arranged for senior civil judges hailing from all over the country including Azad Jammu and Kashmir and Gilgit-Baltistan at the Federal Judicial Academy, Islamabad on Saturday, 13th October, 2012.

He said: "Justice and its effective dispensation is the duty of every State. The States where dispensation of justice is faulty or not upto the mark fall in the category of failed states. I consider the good governance and justice at par and inter-dependent because you cannot achieve good governance without dispensation of expeditious and inexpensive justice".

He said: "In the light of Quranic verses as well as sayings of the Holy Prophet (PBUH), dispensation of justice is not simply a source of

livelihood for judges and judicial officers but also source of their 'Nijaat' on the Day of Judgment. Therefore, I request you (the young judicial officers) to do the justice even the heavens may fall but I am aware of the circumstances wherein you are administering justice. Working for just and good society is a prophetic mission and you will certainly be rewarded for your efforts for a just and good society not only in this world but also in the world hereafter. Mind it, bearing hardships for the cause of justice is Jihad and have a reward like a Shaheed".

He further said: "Throughout the world, training organizations, in fact, develop the capacity of trainees to meet their particular requirements instead of simply educating them. The high profile of objective of justice can only be achieved when our judicial officers will be sufficiently equipped with necessary techniques and skills of procedure which are indispensible for administration of justice".

Earlier, Mr. Parvaiz Ali Chawla, Director General of the Academy presented his welcome speech and spoke about the content of the course and said such subjects were made a part and parcel of this training course which have utility and expressed his hope for the maximum application of the knowledge and skills acquired here for the speedy administration of justice to the litigant public.

Hon'ble Mr. Justice Khilji Arif Hussain, Judge, Supreme Court of Pakistan observed that as we live in the economic world, awareness about the specialized subjects such as Intellectual Property Rights laws becomes more important for all of us including the judges.

He expressed these views in the inaugural ceremony of one week training course titled "Case and Court

Management and Enforcement of Intellectual Property Rights Laws in Pakistan" arranged for Civil Judges hailing from all over Pakistan including Azad Jammu and Kashmir and Gilgit-Baltistan at the Federal Judicial Academy, Islamabad, on Monday 15<sup>th</sup> October, 2012.

Defining the term Intellectual Property, Hon'ble Judge of the Apex Court said: "Intellectual property is divided into two categories. These include: industrial property and copy right. Industrial property includes inventions patents, trademarks, industrial designs, and geographic indications of source while copyright includes literary and artistic works such as novels, poems and plays, films, musical works, artistic works besides those of performing artists in their performances".

Appreciating the contents of the course, he said: "I really appreciate it, especially, the subjects such as ADR, Case and Court Management".

He also illuminated the young judicial officers about the hazards of piracy and its effects on the local economy of any country.

About management of court and cases, he said: "As far as the management of cases and the court is concerned, civil judges must know the cases which come before them".

Regarding the concept of the Alternate Dispute Resolution Mechanisms, he opined: "The concept of Alternate Dispute Resolution Mechanisms (ADRMs) is not new. There are several Quranic verses in this context which advocate the amicable resolution of the disputes in the society". Hon'ble Judge was also of the view that the ADR leads to harmony in the society.

Earlier, Mr. Parvaiz Ali Chawla, Director General of the Academy presented his welcome speech and spoke about the importance of the training course and urged the trainees to learn with utmost attention and dedication.




He expressed these views in the certificate awarding ceremony of one week course titled, "Effective Financial Management, Control over Process Serving Agency and Environmental Law with special reference to Jurisdiction and Powers of Green Courts, etc." arranged for Senior Civil Judges hailing from all over Pakistan including Azad Jammu and Kashmir and Gilgit-Baltistan, at the Federal Judicial Academy, Islamabad, on Friday 30<sup>th</sup> November, 2012.

Regarding people's trust and confidence in the judiciary, the honorable judge gave an example of the recent request of the Chief Election Commissioner for election problems can be discussed duties of the judicial officers.

As you know, this Academy is expanding, not only in its construction but also in the substance. Now we have back to back training courses here and I hope all of you will get a chance to come here for trainings. I could witness that the people around the world are gone ahead of us in the use of ADR methods Now they call it Amicable/Appropriate Dispute Resolution instead of alternate dispute resolution mechanisms. We have to use these methods so as to provide speedy justice to the people", he advised.

Earlier, Mr. Parvaiz Ali Chawla, Director General of the Academy presented an overview of the course. He emphasized the point

that collective cooperation of all stakeholders of administration of justice system, particularly, bar and bench, was essential for speedy disposal of cases.

### CERTAIN CHANGES NEEDED IN CRIMINAL JURISPRUDENCE






