MANUSCRIPT SUBMISSION GUIDELINES

➤ CLARITY IS KEY

Use clear and easy language in your writing to be understood by any reader regardless of their field or whether English is their first language. Nonetheless it must contain certainty and concept of your research.. Make sure that you've described your methodology and approach; whilst it may seem obvious to you, it may not to your reader. And don't forget to explain acronyms when they first appear.

➤ BE ORIGINAL

Communicate your unique point of view to stand out. You may be building on a concept already in existence, but you still need to have something new to say. Make sure you say it convincingly, and fully understand and reference what has gone before.

➤ BE AWARE OF THE OTHER LITERATURE IN YOUR FIELD (AND REFERENCE IT)

Make sure to tell your reader how your article relates to key work that's already published on same or similar issue. This doesn't mean you have to review every piece of previous relevant literature, but show how you are building on previous work to avoid accidental plagiarism.

When you reference something, fully understand its relevance to your research so you can make it clear for your reader. Keep in mind that recent references highlight awareness of all the current developments in the literature that you are building on. This doesn't mean you can't include older references, just make it is clear why you've chosen it. If you're the author of a non-research article (e.g. a Review or Opinion) you should ensure the references you cite are relevant and provide a fair and balanced overview of the current state of research or scholarly work on the topic. Your references should not be unfairly biased towards a particular research group, organization or journal.

If you are unsure about whether to cite a source you should contact the journal editorial office for advice.

➤ GIVE CREDIT TO OTHERS WORK

Listing authors' names on an article is an important mechanism to give credit to those who have significantly contributed to the work. It also ensures transparency for those who are responsible for the integrity of the content.

➤ DEFINE AUTHORSHIP

The FLJ editor will not decide on order of authorship and cannot arbitrate authorship disputes. It is the collective responsibility of all the individuals who have conducted the work to determine who should be listed as authors, and the order in which authors should be listed.

➤ USE OF FIGURES/DATA

You should only use images and figures in your article if they are relevant and valuable to the work reported. Please refrain from adding content of this type which is purely illustrative and does not add value to the scholarly work.

➤ RESEARCH ETHICS AND INTEGRITY

FLJ values professional research ethics and integrity, hence takes the issue of plagiarism very seriously. Plagiarism is defined as "When somebody presents the work of others (data, words or theories) as if they were his/her own and without proper acknowledgment." For FLJ, this applies to data, images, words or ideas taken from any materials in electronic or print formats without sufficient attribution. The use of any such material either directly or indirectly should be properly acknowledged in all instances. You should always cite your source.
